My husband and I have received notices from the Victims Notification System for months and to this date have seen no evidence of a timely closure in this case.

What has happened to the previously seized items? Why hasn't there been any monetary compensation to any of the victims from any of these seized properties, multiple yachts, the private jet, the race track and other monetary assets? Why haven't the victims seen any compensation?

We are not getting any younger and our financial situation is not getting any better. We struggle daily trying to make ends meet because of this criminal. I'm sure many of the other victims of Michael E. Kelly are in the same predicament as we are. This case has been dragging on for six years and we have yet to see any monetary compensation.

I would like to see a detailed itemized list of all incoming funds and outgoing expenses. It seems to me that someone is profiting from the sale of the assets, but it certainly isn't the victims who need it the most.
